<p><i>Board Member Reports</i></p>	<p>Tom Meskel- The Science Olympiad competition was held at GMS. 47 teams participated with over 900 students from Illinois, Indiana and Wisconsin. More than 40 volunteers helped to make the day a success! Tom will travel to Waukegan on Friday, February 23rd to see a garden project at one of the schools.</p> <p>Stephen Mack- Shared that the Diversity Committee added 3 new members. The committee discussed their next steps and how they will approach diversity as a committee and a district. One of the members volunteered to teach a modified diversity training for</p>

He shared his concerns of a tax freeze and how detrimental this would be to district 46. Representative Yingling agreed to schedule a public forum to discuss property taxes.</p>
<p>Superintendent Report</p>	<p>Ellen Correll- Shared that today students across America were encouraged to walk out of school in a show of support against gun violence and stricter gun laws. She went on to explain, that though the districts hearts go out to all the families in Parkland Florida, the district will look for a safer way to show support.</p> <p>NWEA testing is done. New Business	<p>•Discussion of the Durham Transportation Contract- The Durham contract comes due at the end of the 2017-18 fiscal year. The district has been extending the contract on a 1-year basis with Durham for the past 5-years. Durham proposed two quotes. The first quote was a 6% increase. The second quote was a 5% increase with the agreement that Durham can use some busses that are 13 years old. Currently, the district has an agreement with Durham that busses should not be more than 12 years old. The Board questioned how often busses break down and if they could see a report on this for the last couple of years. The State of Illinois reimburses approximately 60% of transportation expenses. Calculating a 6% increase and the assumed State of Illinois reimbursement, the district would see an increase for the 2018-19 school year, of \$71,286.91.</p> <p>Discussion of the RJB Cleaning Service Contract- The cleaning service contract comes due at the end of the 2017-18 fiscal year. RJB is proposing a two year contract with a 2% increase each year. They are also requesting an additional \$1,285.80 every month to cover the cost of healthcare for 3 employees. The Board questioned if the district can request proof that the additional money is being used for healthcare costs. Chris Bobek, CSBO agreed to talk to RJB.</p>
